CONDITIONS OF SALE

This pup is sold as a pet/companion only.

Purchase price is: The sum of \$1000.00 of which a minimum of \$250.00 is non refundable.

And agreements as noted below:

AGREEMENTS OF SALE

A pet PUPPY is defined here to be a purebred Weimaraner puppy which is in good health at the time of sale, and embodies the characteristics of the Weimaraner breed. This PUPPY is registered / registerable with the Canadian Kennel Club.

The BUYER/S hereby agrees that if at any time the BUYER/S cannot take proper care of the puppy, the BUYER/S must contact the BREEDERS and a additional contract must be made

between the BUYER/S and BREEDERS to:

1. take the PUPPY back or
2. assist the BUYER/S in finding a suitable home for the PUPPY

The BUYER/S agrees to notify the BREEDERS of any changes of address during the PUPPY'S lifetime.

The BUYER/S shall keep this animal in conformity with the local municipality by-laws, and

assume full responsibility for the actions of the above said Weimaraner puppy.

The BUYER/S agrees that the name "GMW" will appear first in the registered name of the

puppy/dog. ie: GMW's Graycee Silver Skies

The BUYER/S agrees to have this male/female PUPPY spayed/neutered at the appropriate age

of 6-8 months, and veterinarian confirmation of this procedure must be supplied to the

breeder **Puppy must not be bred under any circumstances.**

Any violations and/or breach of this agreement will constitute an agreed amount of set fines as follows:

\$1000.00 if documentation is not provided to the breeder by the time the puppy reaches (1)

one year of age and puppy must be immediately surrendered to BREEDERS at the BUYERS

expense and the set fines are due and paid immediately to GrayMist Weimaraners.

The breaching party is responsible for all legal expenses. If this puppy/dog is bred, A 5000.00 fine and ownership and physical possession of the puppy/dog and all the offspring shall

immediately revert to the breeders with no compensation to the buyer/s.

Vaccination record and veterinary care is supplied.

The puppy you have purchased is guaranteed to be in good health and has received the appropriate medical attention and vaccinations up to the time of purchase. The BREEDERS have done everything possible to produce healthy sound puppies by raising them in the best way possible considering there are many factors that can influence growth and development in regards to diet, exercise, socialization, weight gain and veterinarian care etc.

This pup has been inspected by the seller's veterinarian and is certified healthy at the time of sale and all appropriate vaccinations for the PUPPY'S age have been given, and a record of this vaccination history is supplied to the BUYER/S.

The BREEDERS do not assume any liability for any injury to the above said puppy after delivery or pick-up as the BREEDERS can offer no further guarantees once the care of the puppy is no longer under their control.

The BUYER/S agrees to maintain the puppy's health in good condition, and to provide age appropriate yearly examinations, vaccinations, heartworm test, exercise, and proper feeding requirements and any other usual procedures necessary to assure good health.

GUARANTEE

This pup is guaranteed for the first two (2) years of life against any life threatening genetic defects.

. The breeder will provide the buyer/s with medical documentation of all treatment the puppy has received and care recommendations for future health. **We advise when you leave with your new puppy to get him/her checked by the veterinarian of your choice within 72 hrs after pickup/delivery to validate guarantee.** Should any such defect become evident while this guarantee is in effect written proof from a veterinarian of such defect must be presented (and must be verified by seller's veterinarian).

After _____ this guarantee becomes void.

The following two (2) options are available to the BUYER once the problem is verified by the BREEDERS.

1. the puppy will be replaced with a comparable pup at the earliest possible time
2. the breeder will reassume care for the puppy and refund purchase price less the \$250.00, any shipping or miscellaneous charges necessary for transportation, and the costs of the crate and/or any thing given with the puppy.

Veterinarian expenses incurred by the buyer/s will NOT be the responsibility of the breeder
